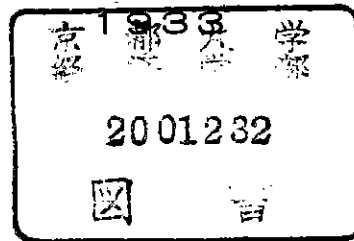

Assistant-Professor Taniguchi took the degree of *Keizaiigakuhakushi* (Doctor of Economics) and was promoted to full professorship. Owing to the resignation of Professors Hideo Miyamoto (Civil Law), Hiroshi Suekawa (Civil Law), Shigeji Moriguchi (Constitutional Law) and Sôichi Sasaki (Administrative Law) of the Department of Law, the instructorships of the above-mentioned subjects are at present vacant although the successors shall be soon appointed.
