Lecturer Kiyoshi Matsui was returned from military service on April 30th.

Professor Mataji Miyamoto of the Hikone Higher Commercial School was appointed Lecturer of our Department on April 30th.

The Society of Economics of Kyôto Imperial University held its Grand Meeting for 1940 on May 25th (the 22th Anniversary of the Founding of the Department of Economics) and the next day.

On the first day's afternoon, a Memorial Public Lecture-Series was given with great success, the programme being as follows:—

In the evening of the same day, a Memorial Dinner-Party was held at the Rakuyukaikan, 74 members attending. After the dinner, which was an unqualified success, the guests heard the reminiscences on the Founding of this Society of Economics from Emeritus Prof. Masao Kambe.

The second day, a series of scientific debates took place between the hours of 9 a. m. and 5 p. m. Before opening the reports, all members at the meeting paid their silent tributes to the late Prof. Juzo Yunoki, Kanseigakuin Uni-

versity, who was gone on May 18th during his preparations for the report to this meeting, entitled "On the Social System of Clans". And then was opened the meeting, much keen discussions were evoked by the following reports:
