African Study Monographs publishes original, multi-disciplinary, academic articles in all fields of African studies. By submission, contributors agree to assign copyright of the accepted version of their submitted paper to the Center for African Area Studies, Kyoto University, in all forms or media now known or hereafter developed including electronic and on-line media.

To minimize publication delays, authors should follow the instructions given below.

Send manuscripts electronically via e-mail as Microsoft Word files, together with the author's personal information on a separate page, including 1) first name, middle name if any, and surname, 2) mailing address, 3) e-mail address, and 4) fax and telephone numbers in case of need. In order to avoid character corruption, the manuscript can be sent as a PDF file in addition to a Microsoft Word file. If special symbols and/or diacritics are used in the text (e.g. phonetic symbols, etc.), a hard copy should also be sent by post. Send all material to the following address:

No manuscript nor part of a manuscript published or submitted for publication elsewhere can be accepted for publication. The decision on the acceptance of papers will be made as rapidly as possible. Papers that are not suitable to the journal (including those which do not follow the instructions given here) will be rejected without detailed review. Manuscripts received will not be returned.

The authors should not have violated the life, physical well-being, human rights, and privacy of the contacts and informants that comprised and contributed to the field data and research upon which the paper was based as well as the content matter of the paper. The authors shall bear the entire responsibility to comply with the letter and spirit of all domestic and international laws, as well as treaties of the relevant nations including Japan, such as those regarding the Access to and Benefit-Sharing of genetic resources of the residents and nations where the research was conducted. The editorial board will reserve the right to ask the authors to submit the relevant memoranda and valid documentary evidence to confirm the above.

Type all material double-spaced on A4 (21×30 cm) size paper. Leave 2.5 cm margins on all sides of each page. Preferably the font should be Times New Roman, 12 point. Do not hyphenate words at the right margin.

An abstract, no longer than 200 words, is required.

Key words (about five words) should be listed immediately below the abstract.

Avoid footnotes. All notes, limited to the minimum necessary, must be arranged in the form of end-of-text note. They should be numbered and typed consecutively after the main text.

Tables must each be typed double-spaced on separate pages. Number tables consecutively with Arabic numerals (Table 1, Table 2, etc.), and provide a short title at the top of each table.

All illustrations, including all photographs, drawings, diagrams, and charts, should be numbered in one consecutive series of Arabic numerals (Fig. 1, Fig. 2, etc.). Never draw illustrations freehand. Each illustration should have a self-contained descriptive legend. These legends should be typed in sequence on a separate page. Provide also a short title at the bottom of each illustration. Photographs should be supplied as digital files with common formatting such as BMP, JPEG, PS, DNG files. All photographs must be of good quality with high resolution and sharp contrast, as they are printed in monochrome. Use the International System of Units (SI) for measurements.

Citations of the literature in the main text should be made with the author's surname and the year of publication:

... (Nishida & Kawanaka, 1972; Itani, 1980;
1994) Fossey (1979) pictured them

For more than two authors, use the first author's name plus "et al.":

Furuichi et al. (1982) set forth

Refer to pages for direct quotations, after a colon following the year:

Leech (1957: 119-120) stated that

... (Pruit, 1960: 19).

The references at the end of the paper should list all works referred to in the text and only those, in alphabetical order of the author surnames. Do not abbreviate journal names. Do not indent the reference entries, although they will be indented in the final print. Below are some examples:
