- The 6th JINSHA information sharing session 'What is the research assessment that leads to advancement of research Envisioning future of research assessment-' (7/26/2019 at Kyoto University)

*A network of SSH researchers and research administrators started in 2014 to think, discuss and act in collaboration with stakeholders to explore better ways to promote SSH research. Currently URAs from 7 universities participate in the network: Osaka University, Tsukuba University, Ryukyu University, Kyoto University, Waseda University, Hokkaido University, Yokohama National University.

Status of research assessment in Japan

MEXT has raised the portion for assessment-basedredistribution of its block grant to 10% (100 billion JPY).

The metrics used for this redistribution are; Ratio of early career researchers; Amount of acquired external grant per researcher; Top journal 10 percentile per block grant cost etc. Metrics based grant distribution has become a reality.


Challenges for HSS Research Common issues with other areas?

2012: 'San Francisco Declaration on Research Assessment' (DORA)

- Academic societies in the field of cell biology, academic journal editors, and researchers took the lead in pointing out the limitations of JIF.
- It is recommended that the scientific content of the paper be evaluated rather than the name of the journal in which the paper is published, and that the value and impact of various research products be evaluated.
- In 2018, the steering committee was reinforced with support from Wellcome Trust, PLOS etc. Recently signed by University of Cambridge in July 2019

2015: 'The Leiden Manifesto for research metrics'

Ten principles that guide the responsible use of metrics, jointly published by Nature in the scientific metrology community.
On the Leiden Manifesto website, in addition to 23 language translations, related trends are being posted on the blog.


