

Kyoto Communiqué on Digital Libraries 電子図書館京都コミュニケ

We, the participants of the 2000 Kyoto International Conference on Digital Libraries have assembled in order to encourage progress towards the following five objectives:

2000年京都電子図書館国際会議に集まった諸国の図書館長および研究者は、これからの世界の電子図書館の健全な発展を旨として、以下の項目に合意した。

1. To develop an information network to promote the cooperation and the exchange of ideas of concerning digital libraries.

世界の電子図書館の相互協力と情報交換の促進のためにネットワークを作る。

2. To work towards universal interoperability standards for metadata to facilitate communication among digital libraries' creators and users.

世界の電子図書館間の相互利用性の拡大のために、メタデータの国際標準の作成への努力を行う。

3. To promote legal protection for fair and other lawful uses of copyrighted information in the digital environment (to no less an extent than that permitted by current legislation and international agreements) and to convey a statement to intellectual property organizations, agencies and publishers.

世界の電子図書館の健全な発展のために、fair useを中心として著作権の権利制限範囲の拡大のアピールを各国著作権関係機関・団体、出版者に対して行う。

4. To encourage government entities and other organizations to strengthen financial support for digital libraries.

世界の電子図書館の発展拡大のために各国政府、関係機関に財政的支援強化を訴える。

5. To conduct an intensive campaign to increase public awareness and use of digital libraries.
